


USB 3.0 Spectra[™] 3022 2-Port USB 3.0 Multimode Fiber Extender

Quick Start Guide

Before you get started, ensure that all the drivers required for your USB device(s) are installed noting this product does not support USB 1.1 or 2.0 devices. LEX = Local Extender, REX = Remote Extender

- In your computer settings, disable the *Suspend* feature.
 - a) For Windows, open the **Control Panel**, then select **Power Options**.
- b) For each of the plans listed, click on *Change plan settings*.

Remove the white sticker from the back of the LEX (if still affixed). Directly connect the LEX and REX with a Duplex LC crossover multimode fiber cable (not included).



Max. distance between LEX and REX: Up to 50m with USB 3.0 storage type devices and up to 100m when using USB 3.0 bulk traffic cameras.

Power the REX with the included adapter and tighten the locking ring.

Select the power plan that you want to customize, and then choose settings that reflect how you want your computer to manage power.




